Alamos Gold Inc

Headed the drafting and execution of several construction and services agreements for the start of operations of "La Yaqui Grande" mine, wholly owned by Alamos Gold Inc., and located in Sonora, Mexico. All payments agreed by the parties in such operation amounted will almost reach USD 145,000,000.00.

GoGold Resources Inc.
